INTRODUCTION

The Universal Basic Education Commission (UBEC) is a regulatory and Intervention Agency established under the Compulsory and Free Universal Basic Education Act, 2004 to provide Financial Grants to States, Local Governments and other Agencies implementing Universal Basic Education programme nationwide.

UBEC had received Intervention Funds from the Consolidated Revenue Fund (CRF) of the Federal Government for the years 2012 to 2016. Part of these Funds were disbursed to the State Universal Basic Education Boards (SUBEBs) to carry out Basic Education activities at the States, Local Government Council, Community and School levels.

In an effort to ensure transparency and accountability, the Commission is inviting reputable and experienced Audit firms to express interest in the audit of the Accounts of the Commission for the Financial Years ended 2015 & 2016 and audit of the funds released to the 36 State Universal Basic Education Boards (SUBEBs) & FCT for the years 2012 – 2016. A competent and reputable Audit firm will also be engaged to consolidate the audit reports from the 36 States and FCT into one National report.
